4. FIRST AID MEASURES

Description of first aid measures

General advice Immediate medical attention is required. If symptoms persist, call a physician.

Eye contact Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. Call a physician immediately. Rinse thoroughly with plenty of water for at least 15 minutes, lifting lower and upper eyelids. Consult a physician. If symptoms persist, call a physician.

Skin Contact	Immediate medical attention is required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash off immediately with soap and plenty of water. Immediate medical attention is not required. If skin irritation persists, call a physician.
Inhalation	Remove to fresh air. Avoid direct contact with skin. Use barrier to give mouth-to-mouth resuscitation. Immediate medical attention is required. If not breathing, give artificial respiration. Move to fresh air in case of accidental inhalation of vapors. If symptoms persist, call a physician.
Ingestion	Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately. Clean mouth with water and drink afterwards plenty of water. Call a physician.

5. FIRE-FIGHTING MEASURES

Methods for containment Prevent further leakage or spillage if safe to do so. Cover powder spill with plastic sheet or tarp to minimize spreading. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up

Use personal protective equipment as required. Cover powder spill with plastic sheet or tarp to minimize spreading and keep powder dry. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Clean contaminated surface thoroughly. Soak up with inert absorbent material. Dam up. Pick up and transfer to properly labeled containers.

7. HANDLING AND STORAGE

Precautions for safe handling**Advice on safe handling**

Avoid contact with skin, eyes or clothing. Wash contaminated clothing before reuse. Do not eat, drink or smoke when using this product. Use personal protective equipment as required. Do not breathe dust/fume/gas/mist/vapors/spray. Use with local exhaust ventilation. Dust at sufficient concentrations can form explosive mixtures in air. Avoid the creation or accumulation of dust when handling and keep away from all possible sources of ignition such as heat, sparks, and flame. Dust control and good housekeeping are required. Dust may carry a static charge. Make sure equipment and personnel are grounded to avoid static discharge.
